# **SUMMARY**

A Draft Constitution document has been in progress and this document was shown at the meeting.

The Draft Constitution has been compiled by the group of Lisa, Alen, Samuel and Ross, keeping an eye on the constitutions of organisations like the international associations for Trail Running, Fell Running, and World Mountain Running.

In this meeting, Cormac took everyone through the components of the Draft Constitution. This is a working document that is meant to be a foundation now and that will be added to over the next year as the tasks and services of the new international Association are defined.

The group agreed that the Draft Constitution should be circulated to countries with established National organisations and also wider to participating adventure racing countries for their input.

The timeline is as follows:

**Friday, 28 July 2023** - distribution of the Draft Constitution for comment. The draft constitution will be circulated with an accompanying letter/ email setting out work to date and process to be followed for establishing the new Association. A note will also be included on how to comment and provide edits, amendments and additional content for inclusion.

Monday, 7 August 2023 - deadline for comments to be received.

Feedback will be reviewed and incorporated and a final draft will be completed and circulated.

# Wednesday, 9 August 2023 - next meeting.

We will soon call for nominations (self-nominations are very welcome) of people to stand for positions on the interim committee of the new International Adventure Racing Association. These people will be voted in at an inaugural meeting and will be tasked with validating members and taking the new organisation through its first year to bring it to the first AGM within 12 months. Note that the elected committee will be 'interim' as their positions will be valid for no more than one year and their tasks will focus on establishing the Association. Thereafter committee positions may be valid for two years or as voted by Members at the first AGM.

# **Next Step**

The Draft Constitution will be circulated for comment. Content will be incorporated ahead of the next meeting.

- Definition of AR (Task Group 2 out for comment)
- Values (to be included in Draft Constitution)
- An inaugural meeting to elect a committee (founding committee can be 4 people like an AR team). Secondments can be incorporated in the first year and other committee positions can be defined then too as the roles and activities of the Body are established.
